for 2015, payable to holders of each of the shares with a par value of €1.00 outstanding at the

ex dividend date, excluding treasury shares held in portfolio at that date.

The dividend will be paid, after deducting any withholding taxes required by law, from 25

May 2016 and the ex dividend date for coupon no. 28 is 23 May 2016. The record date is 24

May 2016.
